Terms and Conditions

Competition Period	12.01am (AEST) on 24/06/2026 to 11.59pm (AEST) on 08/07/2026.
Who can enter?	Only Australian residents who have an active amaysim plan prior to the Competition Period and receive an email from the Promoter to enter this competition.
