

Game of Skill Terms and Conditions for the amaysim's '#amaysimTidyUp' competition

1. Information on how to enter and prizes form part of these conditions. By entering this promotion, participants agree to be bound by these conditions. Entries must comply with these conditions to be valid.
2. Entry is open to all Australian residents over fourteen [14] who are existing Twitter subscribers. Entrants under 18 years of age must have parental/legal guardian approval to enter and further, the parent/legal guardian of the entrant must read and consent to all terms and conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to this Promotion.
3. Employees of the Promoter and their immediate families and agencies associated with this competition are not eligible to enter this competition.
4. The competition commences at 10am (AEST) 23 January 2014 and closes at 10am (AEST) 24 January 2014. Entries will be judged by 29 January 2014 (**Entry Period**).
5. To enter, Entrants must, during the Entry Period:
 - (a) Post a tweet featuring the hashtag '#amaysimTidyUp' that says why the participant wants to review a mobile for amaysim; and
 - (b) Ensure their Twitter profile is set to public from the time they enter the competition through to 29 January 2014 – this is to allow amaysim to see the Entrant's Tweet for judging.
6. Tweets must be posted by the Entrant during the Entry Period. Entries received after the Entry Period for each prize will not be considered for the competition.
7. A maximum of three entries per person per day is permitted.
8. This competition is a game of skill. Chance plays no part in determining the winners. All entries will be judged individually on their merits based on being informative, engaging and creative.
9. Entries will be judged by a panel of judges from the Promoter.

Prize

10. The three (3) best entries received during the Entry Period, as chosen by the judges, will each win the opportunity to trial and use one (1) mobile phone (as selected by the Promoter in its absolute discretion) (**Winner Phone**). Winners must write one (1) review of the Winner Phone for the Promoter (**Review**). The winners will have three weeks to use the Winner Phone and write the Review. The Review must be written in accordance with the brief supplied by the Promoter (**Brief**). The winners must sign a contract regarding the use of the Winner Phone prior to being supplied with the Winner Phone.

Once the Review has been submitted to Promoter and is deemed to meet the Brief (as determined by the Promoter in its absolute discretion), the winners will be given the option to either keep the Winner Phone, or to return it to the Promoter in exchange for \$100 amaysim credit. The credit is valid for 90 days from the date it is added to the winners' accounts.

To aid the winners in reviewing the Winner Phones, amaysim will supply the winners with one month of amaysim UNLIMITED (valued at \$39.90, 4GB data included with excess 5c/MB). This is valid for 30 days from the date it is added to the winners' accounts.

11. Should an entrant under 18 years of age win (**Minor Winner**), the Minor Winner's parent/legal guardian must ensure that, and procure the Minor Winner to do the tasks assigned to the Minor Winner in clause 10.

12. The value of the total prize pool is \$1099.95. The prize is not transferable and is not redeemable for cash. The judges' decision is final and binding - no correspondence will be entered into. The Promoter accepts no responsibility for late, lost or misdirected entries or other communications. Entries will be deemed void if forged, manipulated or tampered with in any way.

- Their entry is original and does not infringe the intellectual property rights of any third party; and
- Their entry does not contain any content that is sexually explicit, violent or derogatory of any ethnic, racial, gender, religious, professional or age group, profane or pornographic, is obscene or offensive or violates any law.

Entry details remain the property of the Promoter and to the extent permitted by law, the Promoter shall not be liable for any loss, damage or injury suffered or sustained (even if caused by negligence) as a result of entering this promotion, accepting and/or using a prize, except for any liability which cannot be excluded by law.
