

Game of Skill Terms and Conditions for amaysim's Amazon Alexa Giveaway

1. Information on how to enter and prizes form part of these conditions. By entering this promotion, participants agree to be bound by these conditions. Entries must comply with these conditions to be valid.
2. Entry is open to all Australian residents.
3. Employees of the Promoter and their immediate families and agencies associated with this competition are not eligible to enter this competition.
4. To enter, participants must tell us what amaysim skill they would like us to build for Alexa next, within an entry form on the amaysim Alexa website.
5. The competition commences at 12:00pm (AEDT) Friday 19 January 2018 and closes at 6.00pm (AEDT) Monday 22 January 2018 (Entry Period).
6. Entries must be received by the Promoter during the Entry Period. Entries received after the Entry Period will not be considered for the competition.
7. A maximum of one entry per person is permitted. If an entrant submits more than one entry, the first entry in time will be regarded as the eligible competition entry.
